This is with reference to your application bearing registration no EX-03257-1819 dated 29/06/2017 on the subject cited above.

In this connection, I am directed to inform you that keeping in view the academic interest of the students, extension of general affiliation has been extended upto 31.03.2020 provisionally and the school is allowed to register its bonafide students of class IX/X accordingly as per eligibility and norms of the Board.

However regularization of general affiliation from 01.04.2018 for a period of 05 years will be subject to the outcome of the inspection report and specific compliance of deficiencies, if any, by the school.

Further, it is also informed that on scrutiny of the application of extension and documents submitted by school, the following deficiencies have been observed, which need to be complied by school before the periodical inspection of school and documentary evidences to this effect must be produced before the inspection committee at the time of inspection & duly attested copy of compliance be submitted along with Inspection Committee report.

1. As per New Affiliation Bye-Laws, by including 02 representative of Parent of students are studying in school, 02 teachers from same school and 02 teacher from any other school or college (of whom one shall be woman), School Principal as Member Secretary, at least 50% member in SMC should be woman and 2 CBSE representatives not below the rank of Principal of Sr. Secondary School affiliated with the Board whose nomination should be recommended from the Board and also submitted list of members of School Managing Committee on non-judicial stamp with effect that no member is related to each other in School Managing Committee.
2. 10 PRT teachers are short to appoint more qualified & trained teachers and also to maintain section teacher ratio i.e. 1:1.5 teachers per section at each level. Hence, the school is required to submit a copy of revised staff statement is required to be submitted showing Name, Qualification, Designation, Date of Appointment, Date of Confirmation etc.
3. The school is required to renew the Reserve Fund as per strength of the school in the joint names of Secretary, CBSE and Manager of the school as per provisions of Affiliation Bye-Laws of the Board and copy of FDR may be furnished to the Board for record purpose.
4. The school is required to submit copies of renewed certificates of Fire Safety, Health-Sanitation and Safe Drinking Water duly issued by the competent authorities/concerned department.
5. The school is required to maintain the reserve funds in the joint names of President/Chairman of Society and Manager of the school according to the strength of the students as per provisions of the Board and furnish a copy of FDR maintained on account of reserve fund.

Besides, periodical inspection committee as per details given below has been constituted and inspection of school for the purpose be completed within 60 days of receipt of this letter by any one of the members. The school authorities are requested to contact the member of the inspection committee for an early inspection.

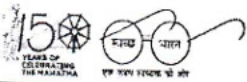

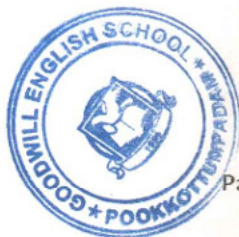

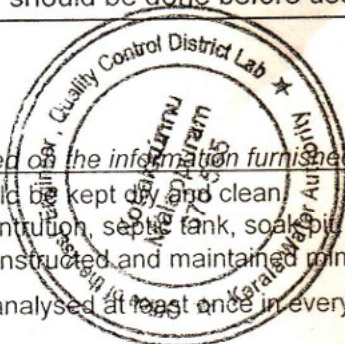
